WAIVER OF LIABILITY - SPORTS PARTICIPATION

I HEREBY, for myself, my heirs, executors, administrators, assigns or personal representatives, knowingly and voluntarily enter in to this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the activity and I hereby release and forever discharge ***New Neighbors of the Greater Memphis Area, Inc.***, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, reps, predecessors, successors and assigns from any physical or psychological injury that I may suffer as a direct result of my participation in the activity.

I am voluntarily participating in the activity and I am participating in the activity entirely at my own risk. I am aware of the risks associated with participating in this activity which may include, but are not limited to: Physical or psychological injury, pain suffering, illness temporary or permanent disability, emotional loss and death. I understand that these injuries or outcomes may arise from my own or others’ negligence. Nonetheless, I assume all related risks, both known and unknown to me, of my participation in this activity.
